Applications are invited from prospective Research Supervisors having Doctoral Degree in Faculty of Civil Engineering Sciences, Mechanical Engineering Sciences, Electrical and Electronics Engineering Sciences, Computer and Information Sciences, Technology, Management, Applied Sciences and Faculty of Architecture., working in a recognized academic institution and/or a Scientist/Engineer/ working in a recognized research Establishment/ Industry.

(A) The requisites of the applicants for consideration as Research Supervisors/Co-Supervisor are as follows:

The applicant shall have Ph.D. Degree from a UGC recognized University in the relevant discipline (Engineering/Technology / Physics, Chemistry, Mathematics and Geology / Management Studies / Computer Applications/Architecture).

The applicant shall be a full-time regular Faculty member working in VTU approved Research Centre at the University Department/ Constituent College/Affiliated College (Autonomous and Non-Autonomous) under VTU / VTU recognized Research Centres at other Academic and Research Institutions / Scientist or Engineer working on regular basis in a VTU recognized research establishment or industry.

The applicants working in other recognised Universities/Academic and Research Institutions / Scientist or Engineer on regular basis in research establishments or industries/and not having approved Research Centre of VTU, will be considered only as Co-Supervisors

In case, the applicant having Ph.D. Degree from Foreign University, he/she shall submit an equivalence certificate obtained from the Association of Indian Universities (AIU) along with the application.

The applicants should have research experience of at least one academic year, after obtaining the provisional Ph.D. Degree.

Applicants must possess the Research publications to his/her credit as under;

- (i)Professor Cadre: Must have published at least five research publications after obtaining the provisional Ph.D. Degree, of which one publication must be in a UGC Care journal/ any journal indexed under SCOPUS/SCI/WoS.
- (ii) Associate Professor Cadre: Must have at least three research publications after obtaining the provisional Ph.D. Degree of which one must be in a UGC Care journal/any journal indexed under SCOPUS/SCI/WoS.
- (iii) Assistant Professor Cadre: Must have at least one research publication after obtaining the provisional Ph.D. Degree and it should be in a UGC Care journal/any journal indexed under SCOPUS/SCI/WoS.

In case of applicants from Research establishments/industries, the requirements would be mapped with one of the above referred cadres.

Applicants who have patents or substantial research grants would be given the due weightage.

(B) Obligations of the applicants after recognition as Research Supervisor/Research Co -Supervisor

The recognized Research Supervisors shall function as Research Supervisors or Research Co-Supervisors to supervise Ph.D./M.S.(Research)/ Integrated Ph.D. Scholars .

The recognized Research Supervisors and Research Co - Supervisors shall strictly adhere to the VTU Ph.D. Regulations - 2020 and to the amendments notified from time to time.

In case, the University allots Candidate/s, without seeking the consent of the Research Supervisors/Research Co - Supervisors, the Supervisors shall accept the responsibility of supervising the Research Scholar/s.

Whenever the Research Supervisors/Research Co - Supervisors change the place of working, they shall inform the same to the University and update the information along with the age of superannuation at the new place of working.

General Instructions to Applicants for submission of applications

The applicants shall submit the softcopy of their particulars by filling the online format available at the home page of online portal https://jnanashodha.vtu.ac.in under "Application for Research Supervisor recognition". from 04:00P.M.on 25-01-2021 to 05:30P.M.on 11-02-2021.

For filing the application, applicants are requested to refer the user manual provided under "Application for Research Supervisor/Co-Supervisor recognition"

The applicants shall also send the printout of the submitted form along with enclosures specified in the application to The Registrar, Visvesvaraya Technological University, Belagavi – 590018.

On or before 15-02-2021

In case, any assistance for completing the online application and submission is needed, the applicants shall submit the query to the e – mail address phd@vtu.ac.in.

Acceptance or rejection of an application shall be at the discretion of the University.

The university has discretionary power of relaxing the eligibility conditions in case of deserving applicants with exceptionally good research profile with respect to patents, research projects executed, grants received etc.

Incomplete applications and not forwarded through the Head of Institution shall be rejected.

This notification is not applicable to Research Supervisors/Research Co – Supervisor who have already been recognized as Research Supervisors by VTU. However, a separate notification will be issued, wherein the existing Research Supervisors/Co-supervisors need to submit the details for seeking continuation of their Recognition.
