VTU RESEARCH GRANTS SCHEME 2021

Sub :Inviting Research Project Proposals under "VTU Research Grants Scheme 2021.

Ref: 1. 153rd EC Meeting Res No 2.3.2, dated 20/10/2020.

2. Hon'ble Vice-Chancellor approval dated: 20/01/2021.

The applications are invited from the teaching faculty members working in all the affiliated, constituent, autonomous engineering colleges and PG centers of VTU for award of research grants under "VTU Research Grants Scheme" for the year 2021. The projects under this scheme shall be sanctioned on the basis of University – Institute Partnership (UIP) model. As per UIP model, Grantee Institution should contribute 25% of the total sanctioned budget.

As per the provisions under VTU Research Grants Scheme 2021, a maximum up to Rs. 25.00 Lakh per proposal may be considered for approval depending upon the recommendation of the Research Project Review Panel.

Conditions for submission of the proposals:

- a) Any faculty member working in any of the affiliated, constituent, autonomous engineering colleges and PG centers of VTU can submit the proposals in the prescribed format with necessary annexure enclosed with this letter.
- b) The Principal Investigator(s) should be full-time employee(s) of the concerned Institution. The maximum age limit for the Principal Investigator should be below 50 years (Fifty).
- c) There may also be co-investigator(s) (maximum up to 2) from same/different institutions/R&D organizations/colleges of different institutions would be working on the project. However, one co-investigator shall be from Institution where Principal Investigator is working.
- d) Institution shall constitute the Institute Level Research Proposal Review Committee (ILRPRC) consisting of Head of the Institution as a Chairperson of

the committee, Heads of all the Departments as members, for reviewing and forwarding the best research proposals from the institutions.

- e) Top four proposals shall be selected and forwarded to VTU for further process of selection by Institute Level Research Proposal Review Committee (ILRPRC) with it's recommendations.
- f) Only four proposals from each institution will be considered for further process of selection.

The proposals should preferably be submitted in the various disciplines such as (i) Mechanical, Material and related Sciences, (ii) Electrical, Electronic and related Sciences (iii) Computer, Information and related Sciences (iv) Civil and related sciences (v) Interdisciplinary Sciences (including Bio –Technology, Nano –Technology, Bio-Medical) (vi) Applied Sciences (Physics, Chemistry and Mathematics) (vii) Management Sciences (viii) Architecture and Related Sciences (ix) Other Disciplines (Silk Technology, Textiles)

Four hard copies of the research proposal on standard A4 size paper prepared as per the prescribed format(Annexure 1) along with the necessary annexure(s) should be submitted to the undersigned on or before **26**th **March**, **2021** and send the soft copy (PDF/Word format) to <u>rgs@vtu.ac.in</u> and <u>rgsvtu@gmail.com</u>.
